#### A. Conditions for List Price Sales Zinc and ZN ALLOY-

- (1) Any quantity of Zinc or ZN Alloy purchased from smelters/stock points during the supply month, will be eligible for following discount: (i) Upto 9 MT: Discount of Rs. 1000/MT
- (ii) More than 9 MT : Discount of Rs.2000/MT
- (2) In case Buyer confirms their quantity for the month of delivery latest by last working day of the month prior to supply month via email to csa\_dx@vedanta.co.in with a copy of email/fax to respective Marketing office (and receipt of such communication having been confirmed by HZL marketing office) and if Buyer completes lifting of the material, within the supply month then Buyer will be eligible for Discount (QCD) of Rs 1000/mt which will be over and above discount mention in point No.1 above.
- (3) In case Buyer lifts more quantity than monthly confirmed quantity, then such additional quantity, will not be eligible for QCD. In case Buyer lifts lower than the monthly confirmed quantity, then the Buyer will not be eligible for QCD.
- (4) The total quantity purchased against specific customer code group within the month shall be considered for discount calculation (5) The discount will be settled by the 10th of the subsequent month.
- (6) Seller shall not be responsible for any quantity variation/deviation arising due to change of Seller's List Price during the month. B. <u>Conditions for List Price Sales</u>

#### (Lead):

4000.00/MT

(1)Any quantity of Lead purchased from smelters/stock points during the supply month, will be eligible for following discount: (i) Upto 9.00: Discount of Rs. 1000.00/MT (ii) More than 9.00 MT but less than equals to 25.00 MT: Discount of Rs. 2000.00/MT (iii) More than 25.00 MT but less than equals to 50.00 MT: Discount of Rs. 3000.00/MT (iv) More than 50.00 MT but less than equals to 100.00 MT: Discount of Rs.

(v) More than 100.00 MT : Discount of Rs. 5000.00/MT

The total quantity purchased against specific customer code within the month shall be considered for the discount calculation.

(2) Discount mentioned at Point 1 above will be settled by the 10th of the subsequent month.

(3) Seller shall not be responsible for any quantity variation/deviation arising due to change of Seller's List Price during the month.
